The Government of Kenya has received Financing from the International Development Association (IDA), toward the cost of the Kenya Youth Employment and Opportunities Project (KYEOP), and intends to apply part of the proceeds for the engagement of consultancy firms whose assignment will be **provision of life skills training** in the KYEOP part under the Ministry of Public Service, Youth and Gender Affairs (MPYG).

The services include development and delivery of a labour market oriented life skills curriculum. The consultant is expected to start as soon as possible and be engaged for a period of 4-5 years.

The Ministry of Public Service, Youth and Gender Affairs now invites **eligible Consultancy Firms (“Consultants”)** to express their interest in providing this service. Interested Consultants should provide information demonstrating that they have required capacity and relevant experience to perform the service. The consultancy should be conducted by a qualified team with practical and recent experience.

Shortlisting criteria are:

- i) Experience in carrying out similar assignments,
- ii) Core business of the firm being in proposed area of assignment,
- iii) Experience in similar conditions in the Sub-Saharan region, and

- iv) Experience and qualification of the firm's key staff – such as the firms Directors. Please **do not** provide names and qualifications of any of the key staff whom you may presume to be relevant to carry out the assignment at this expression of interest (EOI) stage. Specific requirements for key staff, including their qualifications and experience, are not needed at this stage but will be considered in the next stage after EOI evaluation and short listing and will be requested only from firms which will be short listed and invited to prepare and submit technical and financial proposals.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's Guidelines: *Selection and Employment of Consultants* [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers published in January 2011, revised in July 2014 and 1st July 2016 ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest. Consultants may associate with other firms in the form of joint venture or sub-consultancy to enhance their qualifications.

A Consultant will be selected in accordance with the **Quality and Cost Based Selection (QCBS) method** set out in the Consultants Guidelines.
